Montco Sheriff Kilkenny leads deadbeat parent sweep that yields twelve



Norristown, Pa., (March 9, 2016) – Montgomery County Sheriff Sean P. Kilkenny led two teams of deputies and command staff in an overnight deadbeat parent sweep through several areas of Montgomery County on Wednesday, March 9, 2016. The sweep yielded 10 male and two female deadbeat parents, who collectively owed \$77,845.39 in child support arrearages for 17 children.

“I am proud of our warrants teams, who put a lot of work into finding deadbeat parents and holding them accountable,” said Kilkenny. “This is difficult but necessary work and I want them to know that I support them 100 percent.”
