**Nine deadbeat parents arrested in overnight raid**

**Norristown, PA (November 16, 2016)** – Two females and seven male parents were arrested by Montgomery County Sheriff's Office deputies on November 16, 2016 during an overnight sweep of parents, who had failed to pay child support or show up for domestic relations hearings. The parents collectively owed \$104,888.70 in child support arrearages for 15 children.



The following defendants are in custody, and are awaiting a hearing:
