### **\$5,000 REWARD HOMICIDE INFORMATION**



**Homicide Victim Paul Brown**

**The Montgomery County District Attorney's Office is offering a \$ 5,000.00 Reward for information leading to the Arrest and Conviction of the person(s) responsible for the December 25, 2012 murder of Paul Brown. Brown was shot inside a vehicle in the 100 Block of Scott Alley in Norristown, Pennsylvania.**

Montgomery County District Attorney Risa Vetri Ferman and Norristown Borough Police Chief Mark E. Talbot, Sr. announce a \$5000.00 reward for information leading to the arrest and conviction of the person(s) responsible for the December 25, 2012 homicide death of Paul Brown. Brown, a resident of Bridgeport Borough, was shot inside a vehicle in the 100 Block of Scott Alley in Norristown Borough, Pennsylvania.

On Tuesday, December 25, 2012, at 4:40 PM, the Norristown Borough Police Department responded to the 100 Block of Scott Alley for a reported shooting. Arriving officers located the victim, Paul Brown, age 24, inside a vehicle. The victim had sustained multiple gunshot wounds to his body. He was transported to Mercy Suburban Hospital where he was pronounced dead. An autopsy determined the cause of death to be multiple gunshot wounds. The manner of death was ruled a homicide.

The reward is being offered as an incentive for witnesses to come forward in this homicide investigation. As this homicide investigation has progressed, detectives have developed information and believe this incentive may encourage reluctant witnesses to come forward.
