The Petition of The Honorable William J. Furber, Jr., President Judge of the Court of Common Pleas of Montgomery County, 38th Judicial District, represents as follows:

1. The Municipality of Norristown, Montgomery County, contains three Magisterial District Courts within its municipal borders – Magisterial Districts 38-1-15, 38-1-16 and 38-2-09.

- 2. Magisterial District Court 38-1-15 is currently located at 200 West Main Street, Norristown, PA.
- 3. Magisterial District Court 38-1-16 is currently located at 754 E. Johnson Highway, Norristown, PA.
- 4. Magisterial District Court 38-2-09 is currently located at 200 West Main Street, Norristown, PA.
- 5. Pursuant to Rule 101 of the Rules and Standards with Respect to Offices of Magisterial District Judges, a President Judge may petition the Supreme Court to relocate the office of a Magisterial District Judge outside the boundaries of the magisterial district from which the Judge is elected, and combine more than one magisterial district judge's office in a single facility.
- 6. It is respectfully requested that the Magisterial District Judge for Magisterial District Courts 38-1-15 and 38-2-09 be relocated outside of the boundaries of the magisterial district from which the Judge is elected, and that Magisterial District Courts 38-1-15, 38-1-16 and 38-2-09 be combined into the facility located at 601 DeKalb Street, Norristown, PA.
- 7. The proposed location is more suitable and much more affordable than the facilities that are otherwise available within the magisterial district from which the Magisterial District Judge is elected.

- 8. The magisterial district in which the office is located adjoins the magisterial districts of all three magisterial district judges, and is in the center of the Municipality of Norristown.
- 9. Separate courtrooms and facilities for separate staff of the magisterial districts will be provided.
- 10. The relocation of the offices for District Courts 38-1-15 and 38-2-09 will not inconvenience or confuse the public or law enforcement. In fact, the relocation would benefit the public and law enforcement due to the premier accessibility of the location.
- 11. All guidelines and procedures as provided by the Administrative Office of Pennsylvania Courts have been followed in the course of this process.
- 12. WHEREFORE, this Court requests that Magisterial District Courts 38-1-15 and 38-2-09 be relocated outside of the boundaries of the magisterial district from which the Judges are elected, and that Magisterial District Court 38-1-15, 38-1-16 and 38-2-09 be consolidated into a single facility located at 601 DeKalb Street, Norristown, PA.
