Montco Sheriff's deputies get 10 deadbeat parents in overnight sweep

Norristown, Pa., (April 13, 2016) – Ten male parents were arrested on April 13, 2016 during an overnight sweep of parents, who failed to pay child support or show up for domestic relations hearings. The parents collectively owed \$121,091.52 in child support arrearages for 14 children.



A relative of one of the defendants followed the raid team in his truck during part of the night. He was stopped and questioned by sheriff's deputies and an Upper Merion Police Department officer, before being released. Another defendant resisted arrest, but was taken into custody

without incident.

“I can't emphasize how dangerous this job is,” said Kilkenny. “I appreciate everything that our deputies do, to help kids get the money they need from their parents.”
