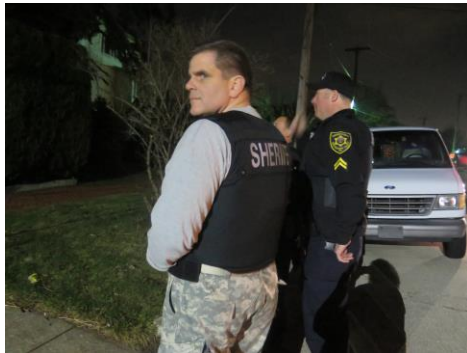

### **Eight arrests in Montco Sheriff's deadbeat parent raid**



**Norristown, Pa. (June 28, 2017)** – Eight men and one woman who collectively owe \$79,775.03 in child support arrearages for 11 children were arrested overnight, during a deadbeat parent raid.

Two teams of deputies and K9s covered Norristown, Pottstown, King of Prussia and Lafayette Hill from 12:30 a.m. to 6:30 a.m. No incidences were reported.

Following is a list of the defendants that were arrested during the sweep, and are awaiting a hearing:
