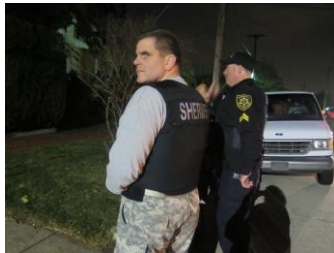

Nine arrests in Montco Sheriff's deadbeat parent raid



Norristown, Pa. (October 25, 2017) – Eight men and one woman, who collectively owe \$74,255.17 in child support arrearages for 10 children, were arrested during an overnight deadbeat parent raid.

A team of deputies, including a K9 unit, covered Montgomery County from 12:30 a.m. to 6:30 a.m. No incidences were reported.
