COMMUNITY HEALTH AND DENTAL CARE (CHDC)

Region(s) served: We serve patients in both Chester and Montgomery County as well as Berks County. We are located at the Coventry Mall in Pottstown, PA.

Purpose/mission: Our organization is a Primary Care office that has numerous services available including Primary Care, OB/GYN, Vision, Dental, Medication Assisted Treatment (MAT), Center of Excellence (COE), case management for adults w/Opioid use disorder diagnosis, Behavioral Health Consults, and pediatrics. We also have a dispensary for medications prescribed by physicians here onsite.

Ongoing work/recent accomplishments: We are a one-stop shop for physical and mental health care needs. Our facility offers transportation to patients in the community who schedule appointments at our location. They are picked up by a CHDC Shuttle and dropped off back home after their appointment at no extra cost. The COE Community Based Care Managers are community based and are now trying to work more in reaching our patients needs in the community whether it be in their home or at a local coffee shop to help them get set up with services here at CHDC.

CREATIVE HEALTH SERVICES

Region(s) served: Located in the Western region of Montgomery County, Creative Health Services serves the Montgomery, Chester, and Berks tri-county area.

Purpose/mission: Creative Health Services provides quality behavioral healthcare designed to empower and promote wellness for individuals, families, and communities.

Ongoing work/recent accomplishments: Opiate Overdose Engagement Team - this team partners with Pottstown Hospital to provide assessment, placement into treatment, and support within Pottstown Hospital for Opioid Overdose Survivors. We also provide Medication Assisted Treatment (MAT) in the forms of Suboxone and Vivitrol to individuals in recovery from opiates. Our Suboxone maintenance program was developed through a grant from SAMHSA. We provide Intensive Outpatient (IOP), Outpatient (OP), individual therapy and Certified Recovery Specialist (CRS) services to our MAT individuals in addition to medication management.

Data collection and reporting for more than 5 years of police and emergency responder Naloxone response data. Department of Justice grant recipient for development of a data coordination and reporting center to compile all available sources of data for all types of overdoses.
