Commercial Photography/Wedding Photo Session Permit

Montgomery County's parks and historic sites have become a favorite location for commercial photographers to shoot weddings and other formal photos. Because of this, certain procedures and regulations must be followed so that everyone's day runs smoothly.

The fee for weddings and other photo sessions by a commercial photographer is \$50 for up to two hours. This is to be paid in advance, at the time of registration. Payment may be made with cash or check made out to "County of Montgomery."

- This fee is non-refundable, no matter what the weather or facility conditions.
- This fee and permit does not guarantee exclusive access to any part of the facility. Areas must be shared.
- This fee and permit does not guarantee an exclusive time frame, other wedding parties and/or activities may be taking place during your session.

Parking

- Please consult with the individual facility for parking procedures.
- Do not park on any grass areas.
- Do not block any gates, driveways or emergency accesses.

Alcoholic Beverages

- There are NO ALCOHOLIC BEVERAGES allowed in this or any County facility.
- If you have any with you, keep them in the vehicle and do not consume them while you are at the site.
