**PROCEDURE FOR FILING A SUMMARY APPEAL**

All summary appeals **MUST** be filed within **30 days** from the date of the decision by the Magisterial District Court, which is the date of the hearing before the Magisterial District Judge. **Note: If you are past your 30 day window, please see the Motion to File Summary Appeal/ Nunc Pro Tunc packet.**

1. There is a **NON-REFUNDABLE** filing fee of **\$65.50** that must be paid at the time of filing the summary appeal, unless permission to file without paying the fee was previously granted by the Common Pleas Court. **Payment is only accepted by Cash, Credit Card, or Money Order at this time made payable to the Clerk of Courts. (We do not accept American Express)**

2. Attached is a **SAMPLE** of how to fill out the Summary Appeal form along with the information for the Magisterial District Courts. Please refer to your paperwork from the Magisterial District Court. If you do not have this information, contact the lower court. (see attached contact information) To obtain the lower court information electronically, please visit: **[ujportal.pacourts.us](http://ujportal.pacourts.us)** website.

3. If the summary offense conviction you are appealing involves a traffic violation for which your license may be suspended, please fill out the Request for Delay of License Suspension form in this packet. We will then send a certified copy of your appeal to Penn Dot. **Note: This is an additional cost of \$7.33 making the \$65.50 filing fee become \$72.83 to file.** If you don't have us mail on your behalf you are responsible for mailing the certified copy of your appeal and cover sheet to PennDOT. If you have any questions regarding points and possible license suspension, call PennDOT at **1-800-932-4600**.

4. If you are found "Not Guilty" or charges are withdrawn or dismissed in the Court of Common

Pleas, you will receive a refund of any monies paid to the Magisterial District Court. The filing fee payable to the Clerk of Courts is non-refundable. If you are found Guilty, you will be billed for any outstanding costs.
