Montco Sheriff's deputies get nine including two "Most Wanted" in DRO sweep through Philadelphia and Norristown

Norristown, Pa., (March 18, 2015) – Montgomery County Sheriff Russell Bono's deputies arrested nine deadbeat male parents, who represented \$108,815.21 in unpaid child support for 13 kids in an overnight sweep through Cheltenham, Philadelphia and Norristown areas on the early morning of March 18, 2015. All of the defendants will be seen by a judge for a deposition hearing.

"The luck of the Irish ran out for these people at about midnight," said Sheriff Russell Bono.

Two of the defendants captured in the sweep, were on the Montgomery County Sheriff's Office's list of "Most Wanted" for child support. Another defendant owed \$44,854.85 for one child.

Fifteen sheriff's deputies went out with a list of 34 defendants, who collectively owed \$474,160.00 in child support arrearages for 47 children. Out of the nine arrested, two defendants were picked up in Philadelphia, one from Conshohocken and seven from Norristown.

"Philadelphia is a big city with a lot of movement, which makes it more challenging to find these people," said Bono. "But, we're going to keep trying, and using social media to get tips."

The MCSO is still looking for these four deadbeat parents who evaded the sweep.



Chykeat Goodley, whose last known address is 205 E. Penn St., Norristown, Pa., owes \$29,765.66 for four kids.



Michael Gatling, whose last known address is 8313 Cheltenham Ave., Laverock, Pa., owes \$45,775.80 for 3 kids.



John McGeer, whose last known address is 404 Magee Ave., Philadelphia, Pa., owes \$30,622 for one child.



Charles Davis, whose last known address is 208 E. 7th Ave., Conshohocken, Pa., owes \$33,989.56 for one child.

“As always, I encourage defendants who have warrants for unpaid child support to turn themselves in, instead of being arrested at home or at work in front of family and friends,” said Bono.
