Montco Joint DUI Task Force overnight raid gets eight

Norristown, Pa., (July 1, 2015) – Montgomery County Sheriff Russell Bono's deputies arrested eight DUI defendants, during an overnight raid on Wednesday, July 1, 2015. Twelve deputies fanned out across Abington, Horsham, Willow Grove, Rockledge, Norristown, Devon, and Huntington Valley and captured the following five males and three females:

- Damian Brown of Norristown, Pa., failed to appear for DUI sentencing.
- Sean Crawford of Rockledge, Pa., failed to appear for sentencing on a DUI charge of having a blood alcohol level of .302 and hitting a pedestrian while driving.
- Thomas Garlanger of Rockledge, Pa., who struck three parked cars has prior drug and criminal charges.
- Anna Nowakowski of Huntington Valley, Pa., failed to appear for DUI sentencing.
- Courtney Pass of Norristown, Pa., failed to appear for sentencing for a DUI charge of having a blood alcohol level of .244 and drug charges.
- Lowell Scheetz of Willow Grove, Pa., failed to appear for DUI sentencing.
- Lucas Stierly of Norristown, Pa., failed to appear for DUI sentencing.
- Marie Wenrich-Schmidt of Blue Bell, Pa., failed to appear for DUI sentencing.

"I just want the citizens of Montgomery County to know that we will be relentless in our pursuit of drunk drivers who fail to live up to their judicial obligation," said Bono. "It's good to know that the people we picked up last night are off of the street and are finally going to deal with the consequences of their irresponsible actions."

Three of the eight arrested defendants pleaded guilty prior to, or during their court appearance and were sentenced. The remaining five defendants, two of which are no longer allowed to drive, had their bail increased and are being held at the county prison.

The raid is part of an ongoing effort of a joint DUI Task Force, which was formed in December 2014 between the District Attorney's Office, the Sheriff's Office and MADD, which targets DUI defendants who have multiple offenses and, who have avoided court appearances.

"Our partnership with the Sheriff has been a critical part of our all-out assault on drunk and drugged drivers in Montgomery County," said District Attorney DUI Unit Capt. Bradford Richman. Defendants, who fail to come to court, often continue to drive and rack up new DUI arrests. Our roads are safer because teams of dedicated Deputy Sheriffs fan out throughout the county to bring these defendants to face the court."

These defendants, who were not captured during the raid, are still wanted by the Sheriff's Office on the following charges:

WANTED FOR DUI CHARGES



Thomas Keyser, whose DOB is 7/24/1980 and last known address was 300 Witmer Rd., Horsham, Pa., is a parole violator, who is wanted for two offenses, including one with a BAC of .191.



Matthew Lieberman, whose DOB is 11/4/1974 and last known address was 2000 Quill Lane, Orelan, Pa., but now is believed to live in New England, has drug charges and three DUI offenses, including one with a BAC of .241.



Hugh O'Donnell, whose DOB is 9/8/1986 and last known address was 254 Cottage Ave., Horsham, Pa., has drug charges and two DUI offenses including one with a blood alcohol level of .178, and.



Nicole Rutledge, whose DOB is 4/22/1981 and last known address was 1184 Grovania Ave., Abington, Pa., has failed to appear on two DUI offenses, one with a blood alcohol level of .241, and on criminal theft charges.



Attila Jasko, whose DOB is 1/22/1966 and last known address was 45 Grove Ave., Devon, Pa., is wanted for failure to appear on two DUI offenses.
