**Montco Sheriff's deadbeat parent raid gets nine**  
*One defendant owed \$46,817.38*

**Norristown, Pa., (July 8, 2015)** – Montgomery County Sheriff Russell Bono's deputies arrested nine male deadbeat parents, who collectively owed \$96,827.90 for 10 children during an overnight raid on Wednesday, July 8, 2015.

Twelve sheriff's deputies, including K9s, who were accompanied by two command staff, tracked across Pottstown, Royersford, Norristown, Spring City, Lansdale, Bridgeport and arrested the following defendants:

- Victor Bellitto of 1011 New Hope St., Norristown, Pa., owed \$1,971.30 for one child.

- John Williams of 1441 Willow St., Norristown, Pa., owed \$46,817.38 for one child.

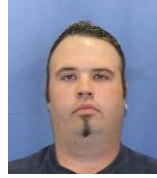
